

Privacy Policy Statement 私隱政策聲明

In this Privacy Policy Statement, “HKJMA” should mean Hong Kong Jewelry Manufacturers’ Association and “JMA Hong Kong” should mean Hong Kong International Jewelry Manufacturers’ Show.

本私隱政策聲明中，香港珠寶製造業廠商會稱為「本會」及香港國際珠寶廠商展覽會稱「本展會」。

HKJMA respects the visitors’ privacy and limits the personal data collected to the minimum required to provide a better service.

Passport / HKID card is requested and verified for security and crime prevention purposes. This personal information will not be disclosed to third parties without your prior approval, unless requested by the police.

Personal data collection 個人資料

All personal data includes, but is not limited to, name, nationality, passport number, HKID card number, address, company name, phone number, fax number, and email address, as well as questions answered on survey or registration forms.

所有個人資料包括，但不限於姓名、國籍、護照號碼、香港身份証號碼、聯絡地址、公司名稱、電話號碼、傳真號碼、電郵地址及於登記表格或問卷調查上的答案等。

Use 用途

All personal data collected during visit of JMA Hong Kong and JMA Hong Kong official show website may be included in the HKJMA database and used by HKJMA or passed onto third party partners for promotional purposes.

所有於參觀本展會及登入本展會的官方網頁時收集得的個人資料，有可能錄入本會的資料庫中，本會有權使用該資料，或因推廣宣傳目的將該資料傳遞給第三方。

If specific information is requested but not supplied, we may be unable to provide the requested service.

HKJMA only retains personal data for so long as it is necessary. However a copy may be archived indefinitely.

Cookies (applicable to online user) 曲奇檔案 (在線使用者適用)

JMA Hong Kong official show website uses cookies to ensure visits to its web sites are smooth and customized for the visitors. Such cookies allow HKJMA to find out more about the use of show websites and user preferences, such as traffic, pages visited and time spent, in order to improve the services. These devices will not contain any identifying or personal data.
